#### GENERAL INFORMATION

Absil is a spray adjuvant created to maximize today's chemistries. This organosilicone and modified seed oil blend bring together two very effective spray technologies in one low use rate mixture. This Absil blend gives the industry best standard surfactant technology for spreading, sticking, and wetting. The combination of modified seed oil and organosilicone helps to increase pesticide absorption and penetration through cell walls. Absil replaces any need for petroleum based crop oils with superior technology. Lower surface tension enhances absorption with each application.

#### HANDLING AND STORAGE

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco. Remove and wash contaminated clothing before reuse. Personal protective equipment: Wear chemical-resistant gloves, long-sleeved shirt and long pants, socks and shoes.

#### DIRECTIONS FOR USE

Shake well before use. Fill spray tank 1/2 full of water and begin agitation. Add herbicides/pesticides as directed by label, while maintaining agitation. After herbicides/pesticides are thoroughly mixed, add Absil at recommended rate. Refer to herbicide/pesticide label being used regarding specific adjuvant use recommendations.

#### FIRST AID

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

**IF IN EYES:** hold eye open and rinse slowly and gently for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

**IF SWALLOWED:** call a POISON CONTROL CENTER: 800-222-1222 or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the Poison Control Center or doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

#### RATE OF ABSIL

- Follow Herbicide label recommendations for adjuvants.
- 1-4 quarts per 100 gallons spray mix.
- Other In Crop Applications - Herbicide, Fungicide, Pesticide, Insecticide - 4 oz to 4 pints per acre.
