Shackle EXT is a premium Non-AMS water conditioner which chelates the metallic ions found in hard water thereby giving farmers a safe option to apply herbicide without volatility drift. The EXT contains our industry exclusive encapsulation technology that increases the life and effectiveness of chemicals that have residual properties. Shackle EXT also contains our next generation polymer drift control technology which improves coverage, decreases evaporation, and increases canopy penetration.

HANDLING AND STORAGE

Do not breathe mist, vapors. Wash hands, forearms and face, clothing thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear eye protection, protective clothing, protective gloves. Absorb spillage to prevent material damage. Store locked up. Store in corrosive resistant container with a resistant inner liner. Dispose of contents/container to a licensed hazardous-waste disposal contractor or collection site except for empty clean containers which can be disposed of as non-hazardous waste.

DIRECTIONS FOR USE

Add Shackle EXT to agitating tank after any dry flowables are mixed and before adding glyphosate to precondition water.

FIRST AID

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
