

# ABSORB 100

## Concentrated Methylated Seed Oil

### GENERAL INFORMATION

Absorb 100 is a spray adjuvant formulated to optimize activity of post-emergent herbicides. Post-emergent herbicides have demonstrated increased effectiveness when used with Absorb 100. This product is designed to replace petroleum-based crop oils, and is formulated from seed oil. Absorb 100 contains proprietary surfactants and emulsifiers for easy mixing in spray solutions.

### HANDLING AND STORAGE

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco. Remove and wash contaminated clothing before reuse. Personal Protective Equipment: Wear chemical-resistant gloves, long-sleeved shirt and long pant, and shoes plus socks.

### CAUTION: KEEP OUT OF REACH OF CHILDREN

### DIRECTIONS FOR USE

Shake well before use. Fill spray tank 1/2 full of water and begin agitation. Add herbicides/pesticides as directed by label, while maintaining agitation. After herbicides/pesticides are thoroughly mixed, add Absorb 100 at recommended rate. Refer to herbicide/pesticide label being used regarding specific adjuvant use recommendations.

### FIRST AID

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.  
**IF INHALED:** move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.  
**IF IN EYES:** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.  
**IF INGESTED:** call Poison Control Center or doctor immediately for treatment advice. Have a person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.  
**IF EXPOSED OR CONCERNED:** Get medical advice/attention if you feel unwell. Immediately call a POISON CONTROL CENTER 800-222-1222.

### RATE OF ABSORB 100

- Follow chemical label recommendations for MSO.
- 1-8 qts. per 100 gal. spray mix.
- For certain in crop applications, lower rates such as these may be needed: 4-16 oz per acre.

Important: This product has demonstrated excellent plant safety; however, not all species and varieties have been tested. Before treating a large area, treat a small area and observe prior to full scale application.
