

# J-LINE

## Nitrogen Stabilizer & Extender

### DIRECTIONS FOR USE

J-Line use rates are based on average soil conditions. Rates may be adjusted based on field conditions.

### APPLICATION RATES

#### UAN

J-Line can be blended with UAN in storage tanks or just prior to application. Recirculate UAN in storage tanks prior to use if preblended.

#### UREA

Applicators must wear proper PPE as indicated above. Use a fertilizer blender or other suitable rotary device when blending urea with J-Line. Ensure that all blender surfaces are clean and dry. J-Line must be applied and blended with urea first before blending with other fertilizer. Allow sufficient time to produce a uniformly blended product. Dye is added to J-Line to aid in determining uniformity of application.

### USE RATE PER TON FERTILIZER

Urea	2-4 qts/ton
UAN	1-3 qts/ton

When conditions favoring volatility exist, or when longer control is needed, the rate may be increased by 1 qt/ton.

### PRINCIPAL FUNCTIONING AGENTS

- Proprietary solvent blend of dicyandiamide (DCD), N-(n-butyl) thiophosphoric triamide (NBPT).
- Supplied as a 20% by weight N-(n-butyl)thiophosphoric triamide and 20% by weight dicyandiamide.

### FIRST AID

**IF SWALLOWED:** Drink 8 – 16 ounces of water if conscious. Call a physician or poison control center immediately. Do not induce vomiting or give anything by mouth to an unconscious person.

Avoid long-term storage at high temperatures. Product will degrade if stored at temperatures above**

Offer rinsed container for recycling at an ARC site (go to [www.acrecycle.org](http://www.acrecycle.org) for locations) or by reconditioning or puncture and dispose of in a sanitary landfill or by other procedures approved by local, state, and federal regulations.**
