### GENERAL INFORMATION

Length EXT uses the best technology available to improve your applications life span. With Length EXT's unique qualities it is capable of extending out the time your chemical remains active. It encapsulates your pre-emerge herbicide, insecticide, and fungicide protecting them from UV decomposition. The encapsulation technology makes your chemical last at least a week longer in most applications. Length EXT is completely safe for in crop use. It incorporates our industry leading Padlock drift control technology making Length EXT an industry leader in drift control and canopy penetration, increasing the effectiveness of all your applications.

### HANDLING AND STORAGE

Spills should be scooped up or wiped up immediately, and spill area flushed with water. Before eating, drinking or smoking, wash face and hands thoroughly with soap and water. Avoid unnecessary skin contact. Impervious gloves are recommended to prevent prolonged skin contact. For operations where eye or face contact can occur, eye protection is recommended. ### DIRECTIONS FOR USE

Add Length EXT first to agitating tank, except with using dry flowables, then add after they are mixed into water solution.

For use with herbicides (including desiccants), insecticides, and fungicides. Refer to herbicide/pesticide label being used regarding specific adjuvant use recommendations.

Length EXT will reduce but not totally eliminate drift. Always follow chemical label directions and precautions. Length EXT is not intended as a substitute for good agronomic practices, and sound application techniques must be used when spraying.

### FIRST AID

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

**IF IN EYES:** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.

**IF EXPOSED OR CONCERNED:** Get medical advice/attention if you feel unwell. Immediately call a POISON CONTROL CENTER: 800-222-1222.

### CAUTION: KEEP OUT OF REACH OF CHILDREN

### RATE OF LENGTH EXT

Always use agitation when adding Length EXT to the spray tank.

- Normal range of use rates can adjust between 1-2 quarts per 100 gallons.
- With low gallon aerial applications, the higher rate is recommended.
- Aquatic Use: Length EXT can be used for aquatic applications including surface water. Always follow tank mix product labels for specific directions and precautions. Length EXT use rate of 0.25% v/v . Do not exceed 0.25% v/v.
