



## Non-AMS Chelating Water Conditioner

### GENERAL INFORMATION

University labs have shown that Shackle chelates metallic ions, including calcium, that are found in hard water; therefore, giving farmers a safe option to apply herbicides without the risk of more volatile water conditions.

### HANDLING AND STORAGE

Do not breathe mist, vapors. Wash hands, forearms and face, clothing thoroughly after handling. Use only outdoors or in a well-ventilated area. Wear eye protection, protective clothing, protective gloves. Absorb spillage to prevent material damage. Store locked up. Store in corrosive resistant container with a resistant inner liner. Dispose of contents/container to a licensed hazardous-waste disposal contractor or collection site except for empty clean containers which can be disposed of as non-hazardous waste.



### DANGER

May be corrosive to metals. Causes skin irritation. Causes serious eye damage. Harmful if inhaled. Suspected of causing cancer. May cause damage to organs (Respiratory tract) through prolonged or repeated exposure (Inhalation).



Obtain special instructions before use. Do not handle until all safety precautions have been read and understood. Keep only in original container.

### DIRECTIONS FOR USE

Always add Shackle to water before adding glyphosate.

### FIRST AID

IF ON SKIN: Wash with plenty of soap and water.

IF INHALED: Remove person to fresh air and keep comfortable for breathing.

IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

IF SKIN IRRITATION OCCURS: Get medical advice/attention. Take off contaminated clothing and wash it before reuse.
