

# CONDENSE + DRA/VRA COMPLETE 1.6

Non AMS Water Conditioner, Humectant, Surfactant, DRA, and VRA

## GENERAL INFORMATION

Condense Complete 1.6 is a new and improved, all-in-one formulation to meet your dicamba spraying needs. This updated formula is the combination of water conditioning agents, humectants, a drift reduction agent (DRA), and volatility reduction agent (VRA). Condense Complete 1.6 contains buffering agents that maintain the right pH in the spray solution. Condense Complete 1.6 includes NPE and APE free surfactants that improve the wetting and retention of pesticides. Condense Complete 1.6 contains no AMS.

## HANDLING AND STORAGE

Harmful if inhaled or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing spray mist. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or smoking tobacco. Remove and wash contaminated clothing before reuse. ## DIRECTIONS FOR USE

Mixing: All spray mixing and application equipment must be thoroughly cleaned before pesticides are applied.

1. Fill spray tank half full of water and start agitation.
2. Add desired rate of Condense Complete 1.6 to water before adding pesticides.
3. Add pesticides as directed by the label, while maintaining agitation.

## FIRST AID

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.  
**IF INHALED:** Remove person to fresh air and keep comfortable for breathing.  
**IF IN EYES:** hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
